### **LEGISLATIVE AND REGULATORY**

**UPDATE** - In the November Champion News brief we reported that the Collaborative Pharmaceutical Task Force final report to the General Assembly had been released and was available on the ICHP website. Turns out we were wrong, but not because we posted the wrong report or because we missed something. In fact, SB2104 which extended the Pharmacy Practice Act to January 1, 2023 and incorporated many of the Task Force recommendations also will reconvene the Task

> Force beginning in January and adds six new members to its ranks! Four legislators, another representative of the Illinois Retail Merchants Association and another representative of organized labor. So we will see what new recommendations the group will present to the

General Assembly with next year's final report! In the meantime, the Governor is expected to sign SB2104 and also HB0659 which limits the patient out of pocket cost of insulin to a maximum of \$100. It will be interesting to see who is stuck with the rest of the price. Both bills passed in the fall Veto Session in October and November.

The November 12th Board of Pharmacy Meeting was a real eye-opener with the announcement that both pharmacists and certified pharmacy technicians will need to complete 1 hour of CE credit on the prevention of sexual harassment for their March, 2019 license renewals. This will be the first time that certified pharmacy technicians will need to provide attestation that they have completed their 20 hours of CE during the last 24 months and the first time for the new additional requirement of the one-hour for sexual harassment. Make sure your staff is aware!
